JUNIOR REPRESENTATIVE PLAYER POINTS RULE

WINTER 2019

Any teams with representative level (VJBL) players are required to comply with a points system based on the level/grade of competition each player competes. This points system applies to all players irrespective of their representative association. There is no restriction on the number of junior blues players per team provided each team complies with the points system.

Each team must comply with the following for the Winter 2019 domestic competition season:

- 14 points total
- Individual player points based on level of competition that player competes in:
 - **VJBL U12 Players:**
 - Victorian Junior Championship (VC) = 4 points
 - Victorian Junior League 1 (VJL 1) = 3 points
 - Victorian Junior League 2 (VJL 2) = 1 point
 - Victorian Junior League 3+ (VJL 3+) = 0 points
 - **VJBL U14, U16, U18 and U21 Players:**
 - Victorian Junior Championship (VC) = 4 points
 - Victorian Junior League 1 or 2 (VJL 1&2) = 3 points
 - Victorian Junior League 3 or 4 (VJL 3&4) = 1 point
 - Victorian Junior League 5+ (VJL 5+) = 0 points
- Clubs must submit nomination forms for all teams with representative players within 5 days of submitting team registration.
 - Any modification to team lists after registration requires approval from FDBA. Teams seeking modification approval should allow no less than 72hrs for response from time of submission
 - Clubs that do not submit nomination forms and disclose all representative players will forfeit any applicable registration fee discounts (inc. early bird rates). This is applied to all teams from the club
- Points are based on division player competes in **VJBL 2019** competition
 - All players that play at least one round of VJBL 2019 championship season competition carry points through until the end of the Summer 2019/20 season
 - This includes players that are not trying out for 2020 representative programs
- FDBA reserves the right review and adjudicate in the best interest of clubs, teams, players and the overall competition if the stipulations within this ruling are found to be not applicable or serve the intended purpose of the ruling
